Sanction is hereby accorded to the temporary appointment of Mr. Mohd. Maroof S/o Late Mushtaq Ahmed (Ex-Class-IV) R/o Barhoon, Tehsil Thanamandi & District Rajouri under SRO-43 as Class-IV (Lib. Bearer) in the pay Level of SL-1 (14800-47100) in School Education Department, District Cadre Rajouri, in relaxation of qualification bar in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Rajouri, within 21 days and shall be allowed to join only after production of the following documents/certificates (in original) to be verified subsequently:-

1. Academic qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical officer of the District.
4. Domicile Certificate issued by the competent authority.
5. Dependent certificate issued by the competent authority.
6. All other relevant documents as are required under SRO-43/1994.
7. No loan certificate under self employment scheme from DIC concerned and Employment Department
8. Category certificate, if any.

The appointment of the appointee, shall further be subject to the following conditions:-

A. That he shall give an undertaking in the shape of an Affidavit to the effect that:

- i. In case adverse report about his Character and Antecedents is received from the Inspector General of Police (CID), J&K to whom a reference shall be made by the Director School Education, Jammu, he shall have no right to claim his



appointment as Class-IV (Lib Bearer) and his appointment, as such, shall be deemed to have been cancelled ab-initio;

ii. If, on verification, genuineness of the certificates produced by the appointee are proved fake or forged, the claim of the appointee for appointment shall also be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.

- B. The Salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- C. The appointee shall be initially on probation for a period of two years.
- D. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- E. If the appointee fails to join within a period of 21 (twenty one) days from the issuance of this order shall forego his right to his appointment which shall be deemed to have been cancelled ab-initio without any further notice.


